# 6. BOG Budget Discussions

Ms. Boyle presented the 2017-2018 draft budget along with last year's budget with the actual figures as of April 1, 2017, and the estimated at year end of June 30,2017. Ms. Boyle stated the Grand List was \$139,765,490.00. She than reviewed the proposed budget line item by line item. Ms. Boyle stated that the draft budget shows an increase to the clubhouse line item from \$5,000.00 to \$10,000.00 for a new roof for the clubhouse, Playground line item from \$2,500.00 to \$10,000.00 for landscaping at the clubhouse, and Capital Expenditures of \$35,000.00 for survey costs, White Cap parking-repave, Lines- White Cap ROW, SeaBreeze Railings/ Walkways and Backboard. Also the Audit fee had increased along with Insurance and Grass cutting.

Ms. Boyle reported the mill rate would increase from 1.49% to 1.6% in the proposed budget. The Bank Balances as of February 28, 2017: Checking and Sweep accounts \$96,724.00; Long Term Capital \$86,234.00

Discussion took place regarding the increase in the Insurance cost and Ms. Cahill asked if the Board could have the Insurance Agent come to a meeting and speak to the board. Mr. Pillion asked if the White Cap parking lot would be resealed and lines painted before the summer season starts. Mr. Sheehan stated that he did not think that the parking lot needed to be done, and it had been brought up at the last meeting. Mr. Fountain did not think there was any reason to repave the lot right now just hot tar to fill in the holes. Mr. Sheehan agreed.
