. Report from Zoning Enforcement Officer - Jim Fox

Mr. Fox presented his report (attached)

Mr. Fox reported on the hedges/bushes safety and stated it has been the major topic with the Board of Governors and with the Zoning Commission. It got to the point where our First Selectman was asked to get involved and then Joe Bragaw, the head of public works for the town of East Lyme got involved. Mr. Fox drove around with Mr. Bragaw today and they identified 5 or 6 properties that the town considers a safety issue. The town is concerned with the safety issue and not Black Point's regulations. Mr. Fox said he would reach out to the owners before the town contacts them. The town said they will send letters to the homeowners and if they do not do anything then the town will step in and take care of them.

Mr. Fox also reported that Mr. Bragaw looked at some of the stop signs that are not close to the stop line. The town will move some of the stop signs closer to the stop line. Some stop signs cannot be moved because of the curve on the roads. The intersection at Sea Crest and Sunrise is one of the streets where the stop sign cannot be moved.

Mr. Bragaw also informed Mr. Fox that the town will be putting in a crosswalk at South Beach.
