This excludes the tennis courts, allowing the Black Point adult population to use them for regular Pickle Ball play on Monday and Wednesday mornings from 10 - noon.

I am once again writing you about pickleball in anticipation that the subject may be on the agenda of the Board of Governors meeting this Thursday. I will be in attendance along with some of the other pickleball league members should that be the case. We are looking for an update on this issue and will be there to address any remaining questions or concerns. I would also like to address three issues that came up during the last BOG meeting.

- 1. The pickleball courts are different than the other facilities such as the bocce court and the basketball court. The pickleball courts are contained by a high fence and accessible through a back gate at the edge of the property. As we have already demonstrated, the courts can be accessed and used without having any impact on the children attending camp. I have not encountered anyone who considers this a safety risk and have a hard time accepting that premise.
- 2. I don't believe the general comparison noted in the minutes of 100 kids to 20 plus adults is valid. In assessing this situation, I feel a more valid comparison would be the number of kids who wanted to use the courts during camp hours, which appears to be zero, to the number of adults who want to use the courts.
- 3. The last issue is dealing with other people who wanted to use the courts during club who are not members of the pickleball league. I think this could be reasonably dealt with by a rule such as the following, since use of the courts during club requires special procedures and that people in the area be known. "Only Black Point-sanctioned leagues are allowed to use the courts during club."

We would like to see this issue on the agenda, if possible, and hopefully formally resolved. Please let me know if this issue will be on the agenda so I can inform the other interested parties and make appropriate plans.

Offered Solution:

Clarify definition of rec area (playground) to exclude the tennis courts and bocce court, and add that access during pickleball hours of Monday and Wednesday are via Billow.

Points of justification:

- Pickleball participation is growing and the time of 10:00 am is the optimum time
 - o Less heat and sun exposure
 - o We expect interest in pickleball to increase in the coming years and convenience of the 10:00 time is important.
 - o The 10:00 time has proven convenient for all age groups thus growing the number of participants
 - o Pickleball has been played for the previous five years without incident.
- Pickleball participants are all known BP residents and tax payers
 - o No threat or liability to rec participants
 - o A benefit to rec participants since some of the players are doctors and nurses (should an emergency arise at the playground)
 - o Pickleball players consider this an amenity and a right.
 - o Pickleball players contribute to the maintenance and upkeep of the tennis courts.
- Tennis (pickleball) court is fenced off from playground and will be accessed by Billow road entrance during rec hours/days. Provides a barrier between rec area and players.
- No vehicles are driven on the playground during pickleball hours (10:00-12:00 am) Monday, Wednesday and Saturday) unlike bocce which is played during some rec events on Fridays.

We suggest accommodating both pickleball and rec as has been the case this summer and for the previous five summers. There should be no change as there were no incidents or problems.

Subject: Question Re Last Night's BOG's Decision

Dear Board of Governors,

For the last two years, I have been a part of the 10AM pickleball group that plays on Monday, Wednesday and Saturdays. It has been wonderful getting to know other people living in Black Point and playing a game that I love. I was so happy when I saw the notice in the Black Pointer last year that there were others who enjoyed the sport as much as I did and that we could get a group of people together to play 3 days a week. The group has grown to 10+ people—all Black Point residents—who play regularly.

You can imagine our disappointment when we heard on Wednesday that we could no longer play at 10AM owing to the fact that the 9-12 year olds wanted to use the courts. I understand that it is important for kids to get exercise, but it is also important for us older folks to get exercise too. Many of the people we play with are retired and moving the time to play to 11:30 in the summer is frankly a health risk to many of us.

We were hoping that sharing the days we played with the 9-11year olds would be a satisfactory compromise but was told that this was voted down by the board last night. I understand the bylaws note that the playground area is reserved for camp during the summer, but do not see anything that mentions the tennis courts. With so many recreational activities the kids can do on the playground, why do the 9-11 year olds have exclusive use of the courts Monday – Thursday mornings even if they are not using the courts! This doesn't make sense to me. Can't we simply divide up the days giving the kids Tuesday and Thursday and the older taxpayers Monday and Wednesdays?

Many of us have been long term residents of Black Point and being senior citizens, we don't have kids going to camp and frankly don't utilize many of the services available. Even so, we are happy to pay our annual taxes so these activities can be offered.

I hope you will reconsider this decision – it is so disappointing to many of us that we are unable to play just when we got a great group together and now will have to find another place to play. I am very disheartened by your decision and would appreciate a response so I can better understand your reasoning. If it is easier, please give me a call at 949-244-9675 – I am happy to chat live about this.

Set up for the BP MahJong Ladies weekly get-together (Ms. Kenny/Ms. Zuk) every Thursdays 1p to 4p.


Waiting on product lighting from Jamco for relamping basketball court with high efficiency *LED* lighting at = \$760 (Approved) and benches for Hard courts.

Removed two fishermen from South Beach at 9:30am on Labor day weekend.


Sweep, roll and groom clay tennis courts on the weekends.





Presented to BOG and had site visit with BOG members and discussed a more permanent solution to remove hazard and replace with two stairs AND a railing.







Gathered bids to replace South Beach ramp with concrete-formed steps. Bid submitted by Mike Nebelung/Phil Harrison (Classic Concrete) as low bid - \$3,000. To begin after Labor Day. Railing will then be added at approx. \$900. Chuck Casey was over bid and his solution was to use timbers at approximately the same price. Consensus is to use formed concrete using a trustworthy concrete company. This is a request to proceed for such repairs to ramp.

There were 31 beach cleanings during the month of August 2021. Removed 3 large loads of heavy seaweed in late August.

Used Mike Nebelung to replace gangway ramps at all beaches after passing of hurricane Henri.

Removed 2 docks, 2 Swim Rafts including 2 safety lines, 2 Swim or "Geese" lines and 10 SWIM Buoys all were taken to WhiteCap lot to be cleaned, repaired and stored.

Recently John Cellino and myself met with Dave Putnam director of the East Lyme Parks and Recreation, here are some of the questions and his answers to questions I asked. Q-Is the handicap access mat at Hole in the Beach the only one the town owns? A- yes Was it purchased with town funds or a grant? A-the town purchased it no outside funding was available, but we do have two mobi- chairs that were purchased with a joint donation from three civic organizations in town Q - How long is the mat A-80 feet and it is positioned next to the rock jetty at Hole in the Wall Beach Q-do you anchor it in place A- yes with the appropriate anchors Q-Do you use a roller to roll up the mat? One man uses the mobi chair on the mat to go swimming daily all Summer, the mat stays on the beach from Memorial Day until Labor Day Q- Do you secure the mobi- chairs at the beach overnight? A- No, not with the acts of vandalism that occur these days, we roll them to the service building where they are stored locked up every night Q- Would you purchase a mat just to access the beach area A-No the mats were designed to get people to the water.. Some facts a 5X 50 ft mat is \$2,019.00 a n 80 ft mat is \$3,289.00 A mobi-chair cost is \$1,849.00 Things for the board to consider. Where do we locate it? How do we install a mat and still keep the beach groomed? The mat cannot be driven over by any beach cleaning equipment per the manufacturer. Who is going to sweep it off with a broom to keep it clean (this is the recommended method to keep it cleaned by the manufacturer)? Can users deal with a short walk on sand to access the mat? These are just some issues I have thought of I'm sure the board members have more.
