Note The Commission briefly discussed what the appropriate effective date would be for the new regulations.

Mr. Horoho asked if he knows of any imminent applications working under the old regulations, that might be impacted by the new regulations, and Mr. Ventres replied no, that people have been relatively apprised and have come an eye on the drafts as they've been posted to the website.

He added that he's been asked questions but he's aware of nothing forthcoming that would have to be altered because of the new version. Mr. Horoho said if that is the case, he thinks December 1st is an appropriate effective date.
